# Membership updates

- 1st year OT: 27 (+1)
- 1st year OTA: 7 (+1)
- o OT: 371 (-3)
- o OTA: 80 (+1)
- Retired: 2 (-)
- Student: 334 (-)
- 38 people renewed their membership and 30 joined in the preceding month.
- o 63 people let their membership lapse and 3 rejoined.
- At this time last year, we had 882 (3,004 including Prospects) active members compared to 839 (3,099 including Prospects) active members as of 10/31/2024.
- This represents a loss of 43 members or a 4.88% reduction in overall membership numbers from last year. This reduction of members is concentrated in the loss of Student members.
- This also represents a growth of 95 individuals in TNOTA's audience or a 3.16% increase in the overall audience.

# Legislative updates

- Highlights from the month's AOTA's Bi-Weekly Regulations Report:
  - The Iowa Board of Physical and Occupational Therapy proposed a regulation to comport with a recently approved law and allow licensees to

- carry forward up to 50% of the required hours of continuing education to the next biennium;
- The Mississippi Department of Mental Health finalized a regulation to allow OTs to provide services in a Certified Community Behavioral Health Clinic (CCBHC); and
- The Washington state Health Care Authority announced its intention to amend regulations related to outpatient rehabilitation services and payment criteria for OT.
- Article by Kim Karr summarizing the Medicare Physician Fee Schedule impact on OT just published to the AOTA website this week. You'll need to log into your AOTA account to read it in full:
