- o 40 people renewed their membership and 29 joined in the preceding month.
- 45 people let their membership lapse and 6 rejoined.
- At this time last year, we had 850 (2,966 including Prospects) active members compared to 839 (3,101 including Prospects) active members as of 9/30/2024.
- This represents a loss of 11 members or a 1.29% reduction in overall membership numbers from last year. This reduction of members is concentrated in the loss of student members.
- This also represents a growth of 135 individuals in TNOTA's audience or a 4.55% increase in the overall audience.

Legislative updates

- Occupational Therapy Licensure Compact
 - 2024 has seen three states, Vermont, Minnesota, and Rhode Island, enact OT Compact legislation, bringing the total to 31 states that have done so. Passing this legislation is a key requirement for a state to join the OT Compact. OT Compact legislation was considered, but did not pass, in Hawaii, Illinois, Massachusetts, and New York. Legislation at press time is pending for 2024 in the District of Columbia, Michigan, and Pennsylvania. As of September 2024, Compact Privilege applications are not yet open. The OT Compact Commission is currently working to develop the infrastructure needed for operational purposes, including the creation of a data system. The OT Compact Commission reports that privileges to practice are expected to be available sometime in 2025.
 - Licensed OT practitioners from compact states can have their applications for licensure fast tracked in other states
- FBI Criminal Background Checks
 - One requirement for occupational therapy practitioners (OTPs) who want to apply for a compact privilege is an FBI criminal background check that must be completed before they can be issued a compact privilege. The OT Compact model legislation includes a requirement that states implement a background check for practitioners seeking a compact privilege. Some states have enacted separate legislation or additional provisions as part of the OT Compact legislation to ensure that the licensing board/state agency has statutory authority to implement background checks.
- Practice Act Amendments
 - The District of Columbia was successful in adding additional language to its practice act relating to scope of practice, although Georgia was unsuccessful in explicitly adding dry needling to its practice act.
- AOTA's Official Documents being updated:
 - 2020 Code of Ethics The revision will focus on the language around the Standards of Conduct to ensure they reflect the needs of the OT profession and promote inclusive and equitable guidelines.
 - Model Continuing Competence Requirements minor language/terminology updates, including clarification on CE course

- presentation formats, and modifications to the calculation of earned contact hours for fieldwork supervision/capstone mentoring.
- The Occupational Therapy Practice Framework: Domain and Process, 4th Edition (OTPF-4) – the survey requesting feedback on the OTPF-4 closed earlier this summer.
